The maximum length of the track should not be more than two minutes and thirty seconds. This does NOT include the fifteen seconds grace period allowed. One copy is a back-up copy. Both copies must be labeled with delegate's first and last name and have the music "cut" or edited precisely as it should be played. Delegates are responsible for rental and purchase of all instruments, equipment, costumes and props used in their performance. Arrangements for use of such equipments etc. must be made prior to arrival at the competition.

Delegates agree to abide by all federal, state, and local laws including, but not limited to, copyright laws and laws relating to unauthorized duplication of recordings.

Delegates must agree to allow their name, voice, likeness and submitted recordings to be used and potentially broadcast by the Miss Black Iowa USA Pageant during this contest, and in subsequent promotional announcements.

Delegates must agree to hold the Miss Black Iowa USA and Miss Black USA Scholarship Foundation and Pageant, Inc., and its subsidiaries and agents harmless for any accident, misfortune, or act of God that arises from as a result of participation in and arrival to/from this contest.
